

took place for the first time under a Level 3 (High) Terrorist Alert 4.



GEOPOLITICAL RISK: INCREASINGLY IMPACTING SPORTS AND EVENTS ORGANIZATIONS WORLDWIDE

GEOPOLITICAL RISK IS BECOMING OMNIPRESENT AROUND THE WORLD.

Whether due to terror attacks, social uprisings, or coups d'état, once-safe countries see their safety being increasingly threatened. As a result, there has been a predictable effect upon sports events organized in concerned territories, including a drop in attendance and by uncertainty on behalf of sponsors and teams alike. Nevertheless, organizers can take several measures to minimize the financial and reputational impact upon their events.



ANALYZING THE EXACT SITUATION OF THE COUNTRY HOSTING THE EVENT

Marsh, in collaboration with Business Monitor International (BMI), issues an annual report analyzing geopolitical risk. The map above emphasizes the developments of geopolitical risk in 2015, and can provide useful information for event organizers, associations, and teams travelling to these territories.

EVENT RISK MANAGEMENT: THE BUILDING BLOCKS OF A SUCCESSFUL EVENT

From a large sporting event or music festival to a small indoor competition, an event brings together a unique combination of factors, including performers, organizers, suppliers, spectators, and sponsors. Inherently, organizing and hosting an event involves a high degree of uncertainty and potential risk.

With an increase in the number of events being held, along with a continuing focus on risk management and controls for safety and emergencies, effective event management is becoming a top priority and a significant concern for event owners and organizers.

EVENT RISK ANALYSIS

Every event comes with a variety of risk issues that could potentially impact normal operations and cause an interruption and/or a financial loss, of both an insurable and non-insurable nature. To assist event owners, Marsh has developed an event risk analysis (ERA) tool that evaluates the effectiveness of risk management controls for any event.

Marsh's ERA tool looks at risk management under the following key areas:

Security

Information technology

Environmental

Financial and management

Contracts

Site services

Loss control (health and safety, fire, medical)

Emergency response planning

The ERA tool examines the current risk management controls in place and evaluates them using a categorized risk rating. The risk rating is based upon an evaluation of the effectiveness of the existing controls that are currently in place, such as policies, procedures, transfer mechanisms, or physical measures that are designed to reduce the magnitude of the risk's impact and/or the likelihood of it occurring.

Risk ratings are derived from a benchmark of the reviews of risk controls used by other major events and venues. This benchmark experience includes the Summer and Winter Olympics, Commonwealth Games, international sport stadiums, sports tournaments and championships, and music concerts.

SPORTS EVENT CANCELLED DUE TO "THREAT" OF TERRORISM

30 APRIL 2015

German police reported foiling an attempted terror attack at the 2015 Eschborn-Frankfurt City Loop cycling race in Frankfurt, Germany. Reports stated that a 35-year-old man and a 34-year-old woman had been arrested in a "Boston Marathon style" terrorist plot to the famed cycling race, at which thousands of fans were expected to attend. The pair were suspected to be Islamic extremists.

A press release issued by the State Office of Criminal Investigation in Hesse stated: "Due to the currently still unclear threat situation and the respect for tomorrow's cycling, this event had to be cancelled for safety reasons. Many people are looking forward, as many years, to tomorrow's tradition event. But with all sporting attractions – because of the risk evaluation and the fact that at the moment still too many questions remain open - the security is essential at this time!" ⁵

SWISS LAWMAKERS APPROVE MORE FINANCIAL SCRUTINY OF SPORTS OFFICIALS

Swiss lawmakers have passed a bill that would subject sports officials to more financial scrutiny by banks in Switzerland.

Switzerland is responding to years of corruption allegations with a set of laws that have become known as "Lex FIFA", which aim to tighten oversight of the approximately 60 sporting bodies based there.

The bill is designed to fight money laundering and is based on guidelines set up by the inter-governmental Financial Action Task Force (FATF).

The bill now includes wording saying that FIFA head Sepp Blatter and other sports executives, such as International Olympic Committee President Thomas Bach, should be treated as "politically exposed persons" – a term justice officials use to define those in positions that could be abused to launder money. 6

CHANGES TO THE WORLD ANTI-DOPING CODE (WADC) 2015

An amended version of the WADC was introduced on 1 January, 2015 and now includes the following significant changes.

WHEREABOUTS PERIOD SHORTENED

The period for a whereabouts missed test and/or filing failure has been shortened from 18 to 12 months. Any combination of three missed tests and/or filing failures, as defined in the International Standard for Testing and Investigations, within a 12-month period by an athlete in a Registered Testing Pool.

PROHIBITED ASSOCIATIONS

A new section – Article 2.10 "Prohibited Associations" – prohibits an athlete from associating with another athlete or athlete support person who has previously committed an anti-doping rules violation. This provision is uncharted territory. An athlete has never before been charged with an anti-doping rules violation for merely associating with someone else.

TESTING METHODOLOGIES NOW "SCIENTIFICALLY VALID"

Analytical methods or decision limits approved by the WADA are now presumed to be "scientifically valid." This new standard will make it more challenging for athletes to successfully demonstrate that testing procedures are unreliable (such as Estonian cross-country skier Andrus Veerpalu did in 2013 when a Court of Arbitration for Sport (CAS) Panel exonerated him and found that the WADA's decision limits for testing hGH were scientifically unreliable).

STRAIGHT TO COURT OF ARBITRATION FOR SPORT (CAS)

The 2015 Code allows for a first instance hearing before a national anti-doping organization or international federation to be bypassed for a single hearing before CAS. All parties must consent.

FOUR YEAR SANCTION FOR "CHEATERS"

"Intentional dopers" who "cheat" will be sanctioned for four years under the new 2015 Code.

LESSER SANCTIONS FOR "UNINTENTIONAL DOPERS"

"Unintentional dopers" (not "cheaters") who unknowingly take a banned substance by, most commonly, ingesting an undisclosed substance in a dietary supplement, have greater opportunity for a reduced sanction under the new Code. 7
