

- A-Level or equivalent qualification with a minimum of 120 UCAS points.
- GCSEs in Maths and English.
- Excellent verbal and written communication skills.
- The ability to build relationships and work in teams.
- Be adaptable and enjoy learning new things to achieve positive results.


