


The Challenge


Collaboration with your Marsh service team can be quick and easy – at no cost to you:

Wiki pages – maintain an insurance manual of servicing procedures.

- Gathering underwriting information and sharing read-only versions with insurers.
- Collaborating on presentations and reports.
