#### **Early Eyes Response Following a Hurricane**

A global manufacturer had multiple installations affected by a major hurricane. Our client evacuated its staff and was unable to assess the damage to its facilities due to access issues. We coordinated drone missions and video collection through a local partner and developed a comprehensive damage assessment report as a result. The report was extremely useful to the client, its primary carrier, and its loss adjuster, given the access challenges. Ultimately, with involvement by claims preparation experts in our Financial Advisory Services (FAS) Practice and our claims advocates, a multi-million dollar settlement was reached.

#### National Flood Response Program Support



A government-backed flood program requires rapid intelligence after each significant flood event, delineating the flood footprint, depth of inundation, and initial assessment of damage severity. For this client, we designed, built, and continuously operate a tailored Visual Intelligence CAT Response service that is on 24/7 standby. It uses satellite, aerial, drone, and street-view imagery combined with flood forecasting and monitoring. We have also established standard operating procedures with the national emergency services to authorize early access for our drone operators. Our support of events to date has enabled the client to respond efficiently and effectively, given insurance a seat at the table with responders, and been used to inform wider resilience activity.



#### **Proof of Loss for a Flood Event**

A restaurant company required visual evidence to support its business interruption claim from a major US flood event. Our client's insurance policy terms stated that evidence of flooding within a defined radius of each restaurant would trigger payment. We analyzed imagery from more than 25 sources, including satellite, drone, aerial, social media, CCTV, and predictive models, generating evidence to support the claim.
